In terms of Section 38 (2) of the Universities Act, No. 16 of 1978 as amended by Act No. 7 of 1987, The Bursar shall, subject to the direction and control of the Registrar, be responsible for the administration of the finances of the University, and maintain its accounts in such form and manner as may be prescribed by rules. He/she shall have the custody of the funds of the University.
